## **Letter from Your State League President** \_\_\_\_\_



Happy New Year!

January is coming to a close and the February 2022 Wyoming Legislative budget session is fast approaching. As I prepared to write this, I took a look at our newsletter from two years ago when we were last gearing up for a legislative budget session and last year's newsletter before the 2021 general legislative session. I noted that

many of our legislative priorities persist. Our work towards Empowering Voters and Defending Democracy remains as critical today as it was when the league was founded 102 years ago.

At our January 2022 meeting the board agreed to continue with the legislative priorities identified in the Strategic Plan approved by the board in November.

Our 2022 legislative priorities are:

- Medicaid Expansion also a priority in 2020 and 2021
- Redistricting in accordance with the census numbers also a priority in 2020 and 2021
- Opposition to Voter Suppression legislation –also a priority in 2020 and 2021; as this is a budget session, there probably will be no proposed legislation regarding Voting

- Education
- Juvenile Justice
- Right to Choose

Our lobbyist Marguerite Herman and our Legislative Committee, led by Margaret Brown, have been attending legislative committee meetings related to these areas of focus as well as other areas related to league positions. This work will continue as the session gets underway on February 14. Your efforts and assistance are also needed in advocating for our positions by contacting legislators and stake holders.

Other up-coming events:

#### **State Convention -**

Two years ago, we were planning to hold our State Convention in Cheyenne at the beginning of May. However, COVID and the ensuing pandemic resulted in a change in plans to a virtual State Convention for both 2020 and 2021.

At this time, we are hopeful that we will be able to hold an in-person convention this spring and have set the dates for April 30-May 1. But, not knowing what COVID may have in store for us, we may again hold it by Zoom.

#### National Convention -

This year the National Convention, held every two years, will be held both on-line and in-person in Denver, Colorado June 23-26. You can find information about the convention on the National League's Management website: https://www.lwv.org/manage-your-league/council-convention

#### Primary and General elections -

The state board Voter Service committee is planning to put together a primary and general election Voters' Guide for State Office and Congressional candidates and an informational flyer on Judicial Retention. Please see the article "What's Happening" in this newsletter for dates related to the 2022 elections.

The committee is also considering an education campaign that shows voters what they need to do to register and to vote. The campaign would also provide information on safeguards against voter fraud. We hope to have the County Clerks participate in this initiative. Ideas for the campaign include a video or videos involving the clerks' demonstrating the process or the use of animations or flow charts.

#### Of note -

In January, the league was approached about supporting or becoming a litigant in a law suit related to filling the

Superintendent of Public Instruction position. The position became vacant following Jillian Balow's resignation to take another similar position in Virginia. The state Republican Party Central Committee, per legislation, is tasked with providing three candidates to the Governor who then selects the person to fill the position until the next election. However, legislation does not dictate what process the Central Committee may use in selecting the three candidates. The 16 plaintiffs in the law suit claimed the process uses by the Republican Central Committee was unconstitutional, violating the federal and state constitution rule of "one person one vote."

Due to the LWVWY's nonpartisan status and the appearance of this lawsuit being a partisan issue, The Executive Committee of the board voted unanimously against becoming a litigant in this action.

Following our decision, US District Court Judge Skavdahl denied the motion,

#### Washington LWV President recommends a book about state legislatures


I have just finished reading Outside Looking In: Lobbyists' Views on Civil Discourse in US State Legislatures. https://labs. wsu.edu/outside-looking-in/ It is masterfully done research involving more than a thousand state lobbyists and public agency legislative officers. They are specific about the degree of weakening of civility norms, the breakdown of capacity for bipartisan problem solving, and the shrinkage of the non-partisan space. What I most appreciate is its linking certain types of structures and 'rules' with this deterioration.

Some of the most insightful comments provided to the research team (more than a dozen scholars from 10 US universities) came from people lobbying their state legislatures for measures favored by their respective state LWV organizations....

The findings of this research are valuable to both political scientists and public affairs practitioners (that's us). The authors have presented this research in several public affairs and legislative conferences....

The League's efforts to promote informed citizenship and fair and informative electoral civic engagement could be advanced by consideration of the survey findings from your state – and could be compared with other states.

# Campbell County League of Women Voters Hosts Speaker on Medicaid Expansion at Their Regular Monthly Meeting

Local League members were informed about Healthy Wyoming's grassroots campaign to involve businesses from every Wyoming county in Medicaid Expansion. Campbell County Healthy WY organizer, Vicki Swenson, invited our group to join her efforts as the first county in Wyoming to ask the business community to sign a letter to support

Medicaid Expansion. Wyoming employers in large and small companies would benefit from having healthier more productive employees at work. Businesses could urge their Wyoming lawmakers to support the WY uninsured that include single moms, caregivers and women working at salaries below the poverty line. Swenson gave details on how to join the Zoom meeting that evening in which campaign materials and a list of community businesses would be shared.

### Acting troupe to perform for historical society

A League of Her Own acting troupe, sponsored by the Cheyenne League of Women Voters, will kick off its 2022 season with a performance for the Laramie County Historical Society.

The group will perform an updated version of its new readers theater production called "An Afternoon with Esther," highlighting the life of Wyoming suffragist Esther Hobart Morris. The original play was featured last summer at a dedication of a plaque marking her Cheyenne home. That ceremony dedicated the first Wyoming marker on the National Votes for Women Trail (NVWT).

The free historical society performance will be 2 p.m. Sunday, February 20, in the Cottonwood Room of the Laramie County Library, 2200 Pioneer Avenue.

Morris came to South Pass City, a gold mining camp in Wyoming Territory in 1869, and was the first woman justice of the peace in Wyoming and the nation. Throughout her

life she supported the antislavery movement, suffrage and equal right for women.

Organized in 2019 to mark the 150th anniversary of Wyoming granting women the right to vote, A League of Her Own has performed its play "Wonderful Wyoming Women Voters" numerous times. Nominated by the Laramie County Historical Society, the play won first place in the fine arts category of the Wyoming State Historical Society's 2020 annual awards program.

For the 2021 Morris house event, the troupe wrote a new script focusing on Esther Hobart Morris. All the characters in the play knew Esther, played by Denise Burke: Julia Bright, of South Pass City, played by Rosalind Schliske; Theresa Jenkins, of Cheyenne, played by Debra Lee, and Amalia Post, of Cheyenne, played by Mary Guthrie. The narrator, played by Keren Meister Emerich, guides the characters in reminisces about Esther.

Vice President, Treasurer, and two elected board positions for two year terms; terms begin following election at the State Convention.


There are also four appointed one year board member terms. In an effort to have a diverse board, candidates are frequently recruited from younger members, less represented local leagues, or members at large.
