- Motions - please submit any motions you plan to make. These will be included in the Convention Book. Motions will also be taken from the floor.

The Convention book will be emailed to registered attendees approximately one week prior to convention and posted on the LWVWY website. Submissions and revisions received after the deadline will be compiled and sent out as an addendum to the Convention book after the convention. The Addendum will also be posted on the LWVWY website.
